District Profile

Akron Central School is located in the charming village of Akron, New York, in the northeast corner of Erie County. The village is situated within the Town of Newstead, which is celebrating its bicentennial in 2023. The footprint of the district is expansive, encompassing nearly 90 square miles with a population of approximately 11,000 residents, including families from two neighboring counties. The Tonawanda Indian Reservation is located adjacent to district boundaries. Native American children have attended Akron Central School since the 1930's.

Akron is only a 45-minute drive to Western New York's major cultural or sporting event venues, or any of the three bridges to Ontario, Canada.

The school campus is nestled below an escarpment on just over 70 acres of land. One building houses all students from Universal Pre-K to Grade 12, with the High School, Middle School, and Elementary School in separate regions of the building, and a shared auditorium and fine arts classrooms front and center. The transportation facility, with 38 buses in the fleet, is situated behind the main building.

The village itself has much to offer: century-old homes, which are neat and well cared for, a beautiful county park as well as a bustling town park, and a nice blend of small and large businesses, scattered throughout. A large industrial complex, housing major industries of regional and national renown, is located within the village, employing over 1000 people. Akron Central enjoys a long and proud history of community, business, and industrial support.

The school district is a considerable employer of local residents with over 300 full and part-time instructional and noninstructional personnel.

The socio-economic status is similar to that found in most suburban, semi-rural communities in Western New York.

Community aspirations for education are expressed by the composition of its Board of Education. The Akron Board is supportive of the school's administration, faculty, and support personnel, while still maintaining cost efficiency.

Cost expenditures for the district compare favorably to those of districts of similar size in Western New York. The Board of Education operates on the principle that a small school district should offer a sound education program by attracting superior educators and teachers and paying them competitive salaries.

Terms of Employment

The Board of Education will offer a three-year contract with renewals contingent upon successful performance evaluations. An initial salary range of \$170,000 - \$185,000, commensurate with experience, will be offered to the successful candidate. Residency in the area is preferred in order to allow for the Superintendent's active participation in school and community events.



District Highlights



- The design phase of the \$29.8 million dollar Capital Improvement Project is currently in progress with submission for State Education Department review set for December. Construction on the new multi-sport turf field stadium, transportation facility addition, and building-wide renovations begin in Spring 2024 with completion expected in time for the Fall 2026 sports season.
- The Tigers participate in nineteen sports including a new Flag Football team for girls, plus Unified Bowling and Basketball. In 2022-23, 19 of 22 varsity teams were named NYSPHSAA Scholar Athlete Teams, and 8 were named Niagara-Orleans League Champions!

 part of our school culture with students actively participating
 in service projects, food and personal hygiene supply
 drives, and other collaborations that demonstrate respect,
 responsibility, caring, and citizenship.
- Our Middle and High School technology classes find success competing in area "Tech Wars" with other schools. Programming robots, learning about high-tech sustainable farming while growing foods in aeroponic garden towers, and building model cantilevered bridges are examples of hands-on projects.
