# A Message From the Superintendent

Dear Akron Central Schools Community:

Over the past year, each of us has had to adapt to many challenges caused by the COVID-19 pandemic and we appreciate the many sacrifices made by students, parents and caregivers. On behalf of the Board of Education and the entire faculty and staff, thank you for your on-going support of our students and our district mission.

In developing the 2021-2022 school budget, the District has been especially mindful of the unique academic, social, and emotional needs of our students in the upcoming school year. As we look to the future, we have placed priority on offering rich and engaging educational programming that will support them to the greatest extent possible. It is imperative that during unprecedented times, students have opportunities to make up for lost instructional time, greater access to instructional technologies, and the opportunity to participate in a wide array of extracurricular offerings. We present a budget that asks voters to allow us to continue the tradition of educational excellence our students, families, and community have come to expect and appreciate.

The impact of the coronavirus pandemic on district operations, educational programming and fiscal planning have been significant. I am grateful to our Board of Education and administrative team for preparing a budget that not only provides for the high quality program offerings our community values, but does so at a tax levy decrease from what was accepted by voters for our current school year. For 2021-22, the Board of Education presents a budget with a 1% tax levy increase that falls well below the District's Tax Cap rate of 1.87%.

The public hearing on the budget will be on Tuesday, May 11th at 7:00 p.m. in the High School cafeteria and will also be streamed via a Zoom meeting video link on the district website. The annual Budget Vote will be held on May 18th from 12:00-9:00 pm in Gym 3. # COVID-19 pandemic redefines many of the year's achievements at Akron Schools

"It was the best of times, it was the worst of times..."

This first sentence of Charles Dickens' novel, *A Tale of Two Cities*, aptly describes the outpouring of good deeds that have demonstrated our humanity in and amongst the global turmoil of the pandemic.

For more than a year, Akron Schools has continued to uphold high standards for excellence in not only academics, but in helping to develop good character traits within each of our students. The people in their lives, including those working in our schools, are beacons – a true source of inspiration during the most challenging of times.

As we look back on the achievements of 2020-21, we are compelled to highlight the extraordinary efforts of many:

**Our administrators** collaborated to develop the re-opening plan that would allow our school to adhere to federal, state, and local government laws and the guidance of health agencies, enacted to minimize the spread of the virus. Their leadership has provided an action plan that would evolve and adapt to the changing requirements of our school community and support those charged with its implementation.

**Our clerical staff** has adapted to the needs of each situation as necessary. Their service and professionalism is exceptional -

creating "Plan A, Plan B, or Plan C" often for the same function! They support our faculty and staff, parents and caregivers, for a multitude of pandemic-related changes with grace.

**Our technology department** has provided hours of professional development for our teachers navigating the technological requirements of the hybrid or fully remote learning models. They tirelessly answer calls from parents, grandparents, and caregivers working with children at home, troubleshoot hardware and software issues, and arrange for Chromebook repairs to allow students to keep up with their remote lessons.

**Our teachers and teacher aides** have exceeded expectations in every facet, continuously going the extra mile to creatively make learning meaningful, engaging, exciting, and fun. (Mostly!) They were and are superheroes in every sense!

**Our students** have demonstrated courage and perseverance daily as they face many new changes and challenges, and certainly some disappointment. However, their resilience has been witnessed and is seen as one of the greatest highlights of the past year. Whether hybrid or remote, their smiles and willingness to keep working hard continues to inspire.

**Our parents and guardians** have immensely supported the efforts of our faculty and staff here at Akron Schools. We salute the parents, grandparents and caregivers who may have reluctantly taken on the role of teacher, counselor, technology wizard, or Google Meet expert! Now, more than ever, we are grateful to call you **partners** in your child's education.







# Here's a sampling of just some of our traditional achievements:



• For the 9th consecutive year, Akron Schools has been named a "Best Communities for Music Education" by the NAMM Foundation! Although the COVID-19 pandemic has affected how the local Akron school community enjoys music events from the school's many ensembles during 2020-21, the musicians and their directors are very proud of their efforts in spite of the challenges. Socially distanced rehearsals have culminated with prerecorded concerts for viewing from the school's website or YouTube.

Many individual musicians accepted the challenge to submit a video recording of a solo audition to the Erie County Music Educators Association (ECMEA). They all agreed that it was much harder performing in front of a camera instead of a judge! 19 Akron students were honored with selection to various All-County ensembles for their efforts and talents, although the traditional weekend festival spent rehearsing and performing could not be held.

Students look forward to performing at unrestricted events that in the past have included Labor Day, Memorial Day and July 4th holiday parades; annual Prism and holiday concerts; the lighted Community Christmas event featuring the Santa's Helpers' Band; Cabaret Concerts and Music & Munchies Orchestra concerts; and musical productions such as last year's Disney's High School Musical for which Akron was lucky to have performed before the pandemic shut down most of the country in March of 2020.



• Despite the limitations forced by the pandemic, the Athletics Department was able to facilitate interscholastic sports for all teams except wrestling and basketball cheerleading. While Section VI shortened some sport seasons in response to county and state health guidance, our athletes put forth exceptional effort and really shined!

Girls XC, Field
Hockey, and Girls
Soccer teams were named
Scholar Athlete Teams (90 and above);
Winter and Fall II team data was not
available at deadline. One senior
was a winner for All-WNY ScholarAthlete selection by Section VI of the
NYSPHSAA with nine seniors earning
Honorable Mention designation for the
Fall I season.

Additionally, Field Hockey, Golf and Girls Swim were Niagara-Orleans Champions and several individual Tiger athletes were honored at the WNY and NYS levels. We were happy to be able to "live stream" swim meets, basketball games and volleyball games to our new athletic YouTube channel as spectators were limited due to pandemic restrictions.

#### Go Tigers!

Thirteen juniors and seniors were selected for the Akron chapter of the National Honor Society and eight Akron seniors were selected to the Erie 1 BOCES chapter of the National Technical Honor Society. Due to pandemic restrictions, the traditional ceremonies were adjusted and pre-recorded events were made available for public viewing.

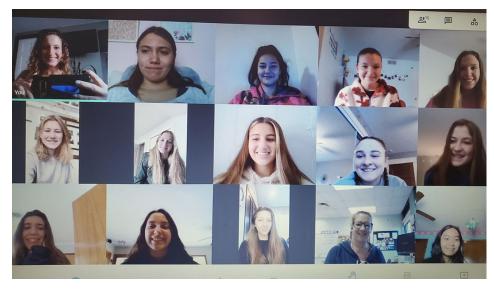
We're proud of faculty and staff members who have been recognized or called upon to serve, including:

 Mrs. Julie Constantino, Health teacher for Akron Middle and High School, was selected the Western Zone's Health Education Teacher of the Year by the New York State Association for Health, Physical Education, Recreation and Dance.

Mrs. Laura Penn, Librarian for Akron Middle and High School, was the recipient of the 2020 Excellence in Library Service award by the Western New York Library Resources Council and was also selected as one of only 120 teachers in the US for the National History Day® (NHD) spring professional development program.

Mrs. Christina O'Malley, Middle School 8th Grade Creative Design and Engineering teacher, who was recommended by the New York State Association for Computers and Technology (NYSCATE) and invited to serve on the New York State Education Department's new P12 Digital Learning Advisory Council.

Mrs. Barbara Goodman, Food Services Director, was honored by recently retired NYS senator, Michael Ranzenhofer, as a 2020 Woman of Distinction for her dedication and leadership in serving our community.



Goodman and the Food Services staff were also honored with the Paul Harris Award, Rotary International's highest recognition for "service above self" for their efforts preparing and distributing meals to our families during the pandemic.

Our students and staff were still mindful of our local community and families or individuals struggling through the pandemic. Although service projects had to be adapted due to the pandemic, they were still meaningful. Here's a sample:

 Mrs. Bernadette Chunco challenged her sixth grade students to demonstrate an act of kindness during the holiday season – and many stepped up by donating toys, books, clothes, and food to charities, made ornaments or cookies for neighbors and relatives, or sent special letters to those unable to visit family due to the pandemic.

Mrs. Chrischell Samolis once again spearheaded "Santa Paws" to collect donations from elementary students for furry friends at the Genesee Animal Shelter and Open Arms Rescue.

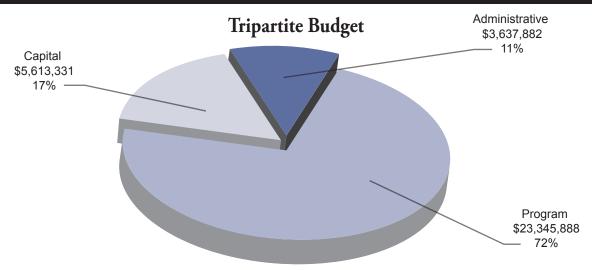

# 2021-2022 General Fund Appropriations



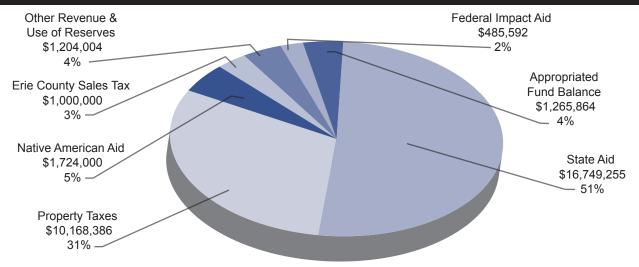

## Contingent Budget Spending

Contingency budget estimates are based on Section 2023 of the Education Law. A contingent budget for Akron CSD for 2021-22 is anticipated to result in a decrease of approximately \$360,241 from the original budget of \$32,597,101.

Under a contingency budget, state law allows a school district to operate the regular instructional program, preserve the health and safety of students and staff, and protect the district's property. Districts are prohibited from spending money on items such as new equipment or nonessential maintenance projects. In addition, a district would be required to charge for public use of their facilities, except when there is no cost to the district.

## STAR Program Information

The New York State School Tax Relief Program (STAR) provides New York homeowners with partial exemptions from school property taxes. ## SAMPLE BALLOT

#### PROPOSITION NO. 1 – 2021-2022 BUDGET

Shall the following resolution be adopted?

RESOLVED, that the budget for the Akron Central School District (the "District") for the fiscal year commencing July 1, 2021 and ending June 30, 2022, as presented by the Board of Education, is hereby approved and adopted, and the required funds therefore are hereby appropriated, and the necessary real property taxes required shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.

#### PROPOSITION NO. 2 Acquisition of School Buses (and Related Equipment)

Shall the following resolution be adopted?

RESOLVED, that the Board of Education of the Akron Central School District, Erie, Genesee and Niagara Counties, New York (the "District"), is hereby authorized to purchase school buses and similar vehicles (and related equipment) for use in the transportation program of the District, including three (3) sixty-six (66)-passenger buses, at an estimated maximum cost of \$121,000 each, and one (1) van-type bus, at an estimated maximum cost of \$63,000 (with such estimated maximum cost reflecting the value of any trade-ins), and to expend therefor an aggregate sum not to exceed \$426,000; and be it further

RESOLVED, that the sum of \$426,000 (which may include certain up-front financing costs), plus an amount for interest thereon, shall be funded by the levy of a tax upon the taxable property of the District and collected in annual installments as provided by Section 416 of the Education Law; and be it further

RESOLVED, that in anticipation of such tax, bonds or other obligations (including, without limitation, obligations arising under leases, lease/purchase contracts or installment purchase contracts having a term of not more than five years) of the District shall be issued or entered into in accordance with applicable provisions of New York State law; and be it further

RESOLVED, that New York State Transportation Aid funds expected to be received by the District are anticipated to offset a substantial part of such costs, and such funds, to the extent received, shall be applied to offset and reduce the amount of taxes herein authorized to be levied.
